

Watch Out! - Convincing People to Take Safety Seriously

A light touch on all the following topics.

When people are ignoring safety precautions, the most obvious diagnosis is apathy: They're not concerned enough about the risk. The first part of the presentation takes that diagnosis at face value. It focuses on two topics: (a) how to grab and hold the attention of apathetic people, and (b) what to say when you have their attention in order to arouse a higher level of concern, change how they see the risk, and thus motivate precaution-taking. The second part of the presentation challenges the apathy diagnosis, considering a range of other reasons why people sometimes ignore safety precautions and suggesting strategies to cope with them. Maybe the safety gear feels uncomfortable or looks geeky; maybe employees are convinced management prefers them to cut safety corners for the sake of productivity; maybe the safety expert's warnings are too reminiscent of parental warnings back when we were kids; maybe the recommended precaution is itself scary to some people (consider vaccines, for example); maybe a little risk enlivens the day. The key takeaway: Before you try to figure out how to convince people to take safety seriously, first diagnose why they're not taking safety seriously already in the particular case at hand.

Waking Up to Fatigue Factors in the Workplace

Did you know that fatigue is 4 times more likely to contribute workplace impairment than drugs or alcohol? A strong case can be built to demonstrate that fatigued workers are a significant occupational safety hazard. Assessment of organizational risk factors, key components of a fatigue safety management system, and current industry fatigue mitigation practices are examined. This session then empowers both organizations and individuals to understand the science behind fatigue and the current best practices they can implement to effectively manage it.

Industry Study on Respiratory Protective Equipment (RPE) for the Accommodation of Facial Hair

A report documenting the efforts of a group of industry volunteers representing Canadian Association of Petroleum Producers (CAPP), Construction Owners Association of Alberta (COAA), ENFORM and the Alberta Construction Safety Association (ACSA) with support from personnel representing Occupational Health and Safety (OHS) division of Human Services within the Government of Alberta and a representative of the World Sikh Organization (WSO) to look into possible alternatives to the clean shaven policies and the usual RPE equipment selected on worksites to mitigate the risks of working in potentially hazardous atmospheres. The report summarized the results of the work performed by this Committee to understand the systems in place for the development and approval of RPE for market use, the setting of industrial and regulatory standards, and the use of Hazard Assessment techniques by employers in Alberta. It also confirmed potential opportunities for change that we have observed which, if pursued, may result in better refinement of these systems and processes with the end result of better addressing the accommodation issues raised by Human Rights Commission.

The Dissenting Voice

Safety people are often put in the position of having to disagree or act as the "devils advocate". This is a critical function of the profession yet one that can drive a wedge between supervisors and safety staff. Disagreement is often not really expected from safety staff and some organizations are just not really structured to tolerate disagreement.

How you express dissent is much more important that what you have to say. In many cases consistently voicing disagreement often leads to the safety person leaving the company.

Delivering bad news or taking a different viewpoint can be a risky business. Dissent within an organization can sometimes have very poor outcomes. The Enron scandal or the Challenger disaster are good examples. The reasons for this and how to safely express dissent are explored by the author of an article with the same title published in professional safety in April 2013.

NORM: How to Understand and Communicate the Risk

In 2000, the Federal-Provincial-Territorial Radiation Protection Committee prepared the Canadian Guidelines for the Management of Naturally Occurring Radioactive Materials. The Canadian Guidelines set out principles and procedures for the detection, classification, handling and material management of NORM for Canada. The Guidelines provide an outline for more detailed NORM management practices and programs. But as a guideline, how are the recommendations interpreted and implemented? How does the theory of the document become a workable practice in the field? And how do we communicate this risk?

With more and more workers becoming aware of NORM as an occupational health issue and with casually related events such as Fukishima in the news media, the question regarding whether working with NORM is safe arises more frequently than in the past. Although in most cases the management of NORM contaminated materials from a health and safety standpoint is very straightforward, companies are finding it challenging to properly assess the risk and communicate it to workers. This challenge is partly due to the general lack of technical understanding regarding radioactive material in the public, but it is also compounded by a general lack of understanding by companies on how to interpret the Canadian Guidelines.

This session will take a look at the facts that need to be communicated to workers and the hurdles that are faced when attempting to communicate the facts. By recognizing the challenges in risk communication it will help organizations target the message to those who need to hear it and in a language they can understand.

Harmonization of Rigging and Hoisting Standards Across Canada

The presentation will introduce the Canadian Hoisting and Rigging Safety Council (CHRSC) and focus on two of its seven major current initiatives:

- 1. the establishment of a national rigger core competency standard;
- 2. a national project to baseline and work at alignment of the referenced rigging equipment standards in occupational health and safety regulations within each jurisdiction.

The Council was formed to determine the best approach to accomplish a harmonization of regulations between jurisdictions. There is a consensus among crane industry stakeholder groups that harmonization of regulations relevant to cranes, hoisting and rigging across Canada would be beneficial to industry, operators, and the public in terms of increased safety, reduced costs, and greater employer and worker mobility. www.chrsc.ca

Evaluation of Protective Clothing

The industrial protective clothing industry is a rapidly growing in four areas: electrical protection, chemical protection, clean room and flame protection. With the growth in the industry there is pressure to provide low cost, durable products in order to maintain or garner market share. There is a great temptation to obtain materials and labor offshore in an attempt to lower product cost. This has resulted in products in the marketplace that are labeled as being compliant to North American and European standards but for the average user or purchasing agent the standards are complex and confusing so interpretation of test results or manufacturers claims is difficult. Test methods or standards for evaluating protective clothing may or may not represent the hazard for which the protective clothing is intended. Limitations on test methods and interpretation of test results will be discussed.

The talk will focus on protection against flash fire and electric arc but will also delve into an area that has been largely overlooked in the protective clothing area; protection against steam and/or hot fluids. Reports from the National Burn Injury Repository indicate that the number of industrial related steam/ hot fluid injuries is of the same order as those associated with fire/flame yet the industry has not yet addressed the market potential. The assumption that materials that protect against flash fire will also work with steam/hot fluids is simply wrong; conventional FR materials provide little or no protection against steam/hot fluids and, in some cases, will aggravate the injuries received.

Considerations for Pre-Employment Testing of Workers

This presentation will look at the evidence base for the use of pre-employment/pre-placement medical examinations and whether the use of pre-employment examinations is driven more by cultural practices than evidence. Is there evidence on their effectiveness in preventing health-related occupational risks? We will look at the inherent problems in screening for certain disorders and diseases as well as potential for bias and other unintended negative effects. We will look at the economic case for this practice and also discuss concerns about denial of employment related to identified risk factors.

Also, what qualifications to look for when selecting a provider for occupational health services. What do designations mean and who can do testing? What do the regulations say?

Wellness of Workers (WoW)

The Wellness of Workers program is designed to identify risk factors that could lead to the development

of chronic disease. Early identification coupled with early intervention result in an increase in quality of life for the worker, less sick time, disability claims for the employer and increased productivity. A healthy workforce is a productive workforce. Alberta's unionized insulators have entered into a six year longitudinal prospective study which we believe will demonstrate that insulators have a higher incidence of cardiopulmonary disease than the general public.

This session will address the recent advancements and developments in relation to technology within motor vehicles and the need to interface technology with the human factor in order to create a harmonic balance between social trends, technology and human behavior. The presentation will engage the audience in the risk factors encountered by every driver and how mediation techniques can better manage a safer transportation environment within out communities. Proactive Safety Leadership: Uncovering Hidden Risks in Workplace Culture

Proactive Safety Leadership: Uncovering Hidden Risks in Workplace Culture

We know unsafe work practices have severe consequences for individuals and organizations including: grief and hardship for those affected by workplace incidents, Financial liabilities, and potential criminal prosecution for persons who directing the work of others. There is an urgent need for leaders to adopt a proactive approach to monitor and manage workforce conditions that impact safety, and take steps to prevent incidents.

A systems approach to workforce safety allows us to assess and maximize enabling safe work conditions and facilitate due diligence through safety leadership. For exceptional safety results, organizations must enable safe work performance. Leaders need to identify and ensure the conditions that promote working safely. Such conditions are "leading indicators" of safety and are embedded in organizational culture. What sets organizations with exemplary safety records apart is having leaders who systematically maximize the workplace factors needed for safe work performance.

It Could Happen to You


Candace uses her personal story of the loss of her left leg below the knee to address the details surrounding what went wrong in her situation...with the hope of making it right in yours.

With her ever-present sense of humour and passion for her message, she discusses how roles played by the education system, the company she worked for, it's employees and management team, resulted in her injury. She discusses the importance in recognizing the opportunities that are constantly presented to us, in our day-to-day lives, to make a choice; safe . . . or sorry.

Candace recalls the details of her incident, as well as the many contributing factors, i.e., poor leadership, lack of training, and unsafe work environment - an unguarded conveyor belt system in her case. However, Candace places great emphasis on her own role and responsibility in what happened in an effort to encourage people to "own" their right to a safe workplace. The absence of Candace's left foot is an ever-present reminder to her and her audiences that pointing fingers and placing blame will not make your limbs grow back. This truth causes Candace to place great emphasis on the importance in landing the leading role in ensuring your own health and safety.

Holding strong in the belief that "no man is an island", Candace explores how we as individuals can begin fostering positive attitudes and changing cultures within the realm of health and safety that can collectively contribute to injury reduction within our workplaces.
